# 1. About Kernel for Word

---

Welcome to the user manual for Kernel for Word, the most effective and convenient .doc file repair tool available that repairs corrupt MS Office Word documents. This user manual comprises step by step guidelines on using Kernel for Word.

## 1.1 Using this Manual

---

This user manual is intended to guide users on using Kernel for Word. We suggest that first time users should read this user manual completely and carefully before proceeding to use the software. ## 1.2 About Kernel for Word

---

Kernel for Word is file repair software for MS Office Word documents. This software repairs MS Office Word document files that become inaccessible due to unexpected system shutdown, bad sectors in the disk, error opening file, power failure, virus attacks, media errors, etc. You might be familiar with the following error messages if you have encountered MS Office Word .doc file corruption before:

- The document name or path is not valid
- Check the file permissions for the document or drive
- General Input/output error
- The file could not be repaired therefore, cannot be reopened

Kernel for Word quickly and effectively resolves the above mentioned errors by repairing corrupt .doc file, keeping the complete document format intact. It restores tables, bullets, embedded images, headers, footers, font style, hyperlinks, OLE objects and all other components of the corrupt Word document.

## 1.3 Salient Features

---

Salient features of Kernel for Word include:

- Efficient repair algorithms to quickly repair even heavy files
- Supports almost all versions of MS Office Word for recovery
- User friendly graphical user interface, no technical skills required
- Supports Rich Text Format (RTF)
- Free demo to test the capabilities of the tool before purchasing it

## 1.4 Who Should Use this Software?

---

The capability of Kernel for Word to repair large sized .doc files makes it appropriate for use by professionals or home users, who keep their important data stored in MS Office Word documents. Software is also suitable for other MS Office Word users, who have lost their important data stored in .doc



files due to .doc file corruption. This corruption could have been caused due to virus attacks, improper system shutdown, installation of unsupported software, media corruption, etc.

## 2. Getting Started

---

Now that you have understood the features and potential of Kernel for Word, you are ready to get hands on experience of the software. To start repairing .doc files, you will first need to download and install this software. It is strongly recommended that before installing Kernel for Word, you should go through the installation pre-requisites for the software so that it can be assured that your computer is appropriately configured to run the software.

### 2.1 Installation Pre-requisites


---

The various pre-requisites for installing and running Kernel for Word can be broadly classified into two major categories – Hardware requirements and Software requirements.

#### 2.1.1 Hardware Requirements:

The hardware requirements for installing the software are as follows:

- Pentium Class Processor
- Minimum 64MB RAM (128 MB recommended)
- 10MB for Software installation
- Disk Space - Enough space to store the repaired files

 You should have at-least 10 MB of free disk space if you want to repair and save a 10 MB.doc file.

#### 2.1.2 Software Requirements:

The software requirements for installing the software can further be grouped into two categories – Operating system requirements and MS Office version requirements.

## 2.2 Downloading Kernel for Word for the First Time

---

After checking your computer with the prescribed system requirements for Kernel for Word, you can download and install the software on your computer. You can buy the full version of the software from any one of our authorized resellers– Element5, Asknet and 2CO. If you want to try using Kernel for Word before buying it, you can download the evaluation version from the following link:

 You can repair .doc files saved on your system by using the evaluation version of Kernel for Word; however, the repaired file will not be saved. To save the repaired DOC file you need to buy the Full version of the software.

## 2.3 Install Kernel for Word

---

After downloading the installer file for Kernel for Word, you can install the software by running the file. To install Kernel for Word:

1. Double-click the Kernel for Word installer.
2. Follow the on-screen instructions. The **Setup Installation Complete** screen will be displayed.
3. Click **Finish** to launch the software.

## 2.4 Start Kernel for Word

---

To start Kernel for Word:

Click the **Start** → **All Programs** → **Kernel for Word**

Alternatively, you can launch Kernel for Word by double-clicking the shortcut icon available on the desktop and Quick Launch icon.

## 2.5 Uninstall Kernel for Word

---



You may need to uninstall and re-install Kernel for OST to PST. You can uninstall Kernel for OST to PST in two different ways:


### **Uninstall from the Windows Start menu**

You may need to uninstall and re-install Kernel for Word. To uninstall Kernel for Word:

1. Click the **Start** → **All Programs** → **Kernel for Word** → **Uninstall Kernel for Word**

A warning message will be displayed.

2. Click '**Yes**' to uninstall Kernel for Word.

 Before proceeding to uninstall Kernel for Word, you must ensure that the software is not running.

### **Uninstall from Control Panel**

You can alternatively uninstall Kernel for Word from the **Control Panel** by performing the following steps:

1. Click the **Start Menu** → **Control Panel** and then double click the **Add or Remove Programs** icon.

2. Select **Kernel for Word** and click **Remove**.

A warning message will be displayed.

3. Click '**Yes**' to uninstall Kernel for Word.



## 3. Software Interface

---

Now that Kernel for Word has been installed on your computer, you can start using the software after getting acquainted with the software interface.

### 3.1 Menu-bar

---

The menu-bar of Kernel for Word comprises two main menus – File and Help.

#### 3.1.1 File Menu

The **File** menu comprises four menu items.

**Menu items in the File menu:**

Field Name	Field Description
Add Files(s)	To select and add the Word file(s) that you want to repair
Repair Files(s)	To start the repairing process
Exit	To close the software

### 3.1.2 Help Menu

The **Help** menu comprises two menu items.

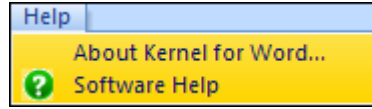


Figure 3.1.2 Help Menu

Field Name	Field Description
About Kernel Word	To view version-related and support information of Kernel for Word
Help	To get the help guide of the software

## 3.2 Tool-bar

---

The tool-bar in Kernel for Word is displayed below the menu-bar. The tool-bar provides a convenient and user-friendly method to perform certain actions that can also be performed by using the menu-bar. Read the information in the table below to find out more details about the tool-bar buttons:

Button	Button Name	Button Description
 Add File(s)	Add Files	To browse and list corrupt .doc files stored on your system
 Repair File(s)	Repair Files	To repair selected file(s)
 Remove Selected	Remove Selected	To remove the selected Word file from the list
 Remove All	Remove All	To remove all Word files from the list
 Help	Help	To open the software help manual

## 4. Repairing .DOC Files

---

Now that you have complete familiarity of the user interface of Kernel for Word, you are ready to repair .doc files. To repair .doc files:

1. Launch Kernel for Word.

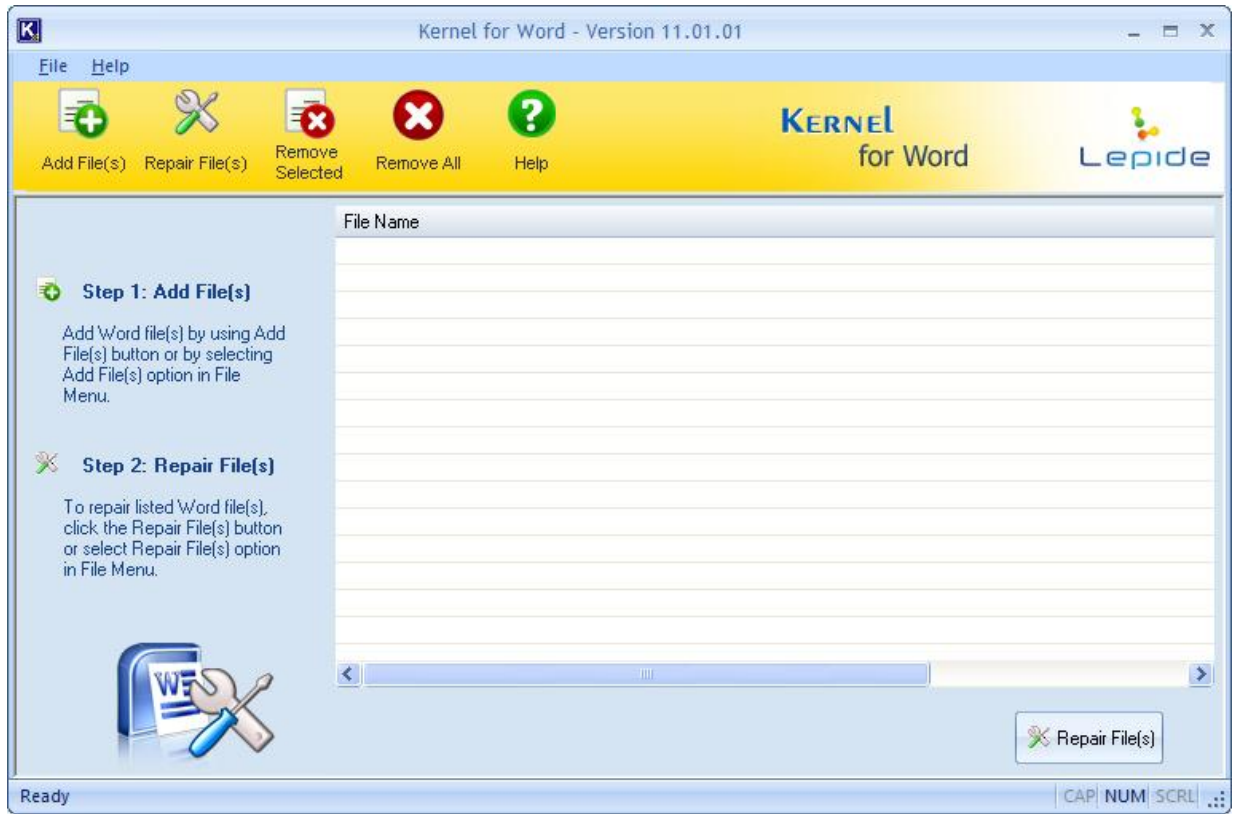


Figure 3.2.1 Main Window

2. Click the **Add Files** button to browse and list corrupt DOC files.

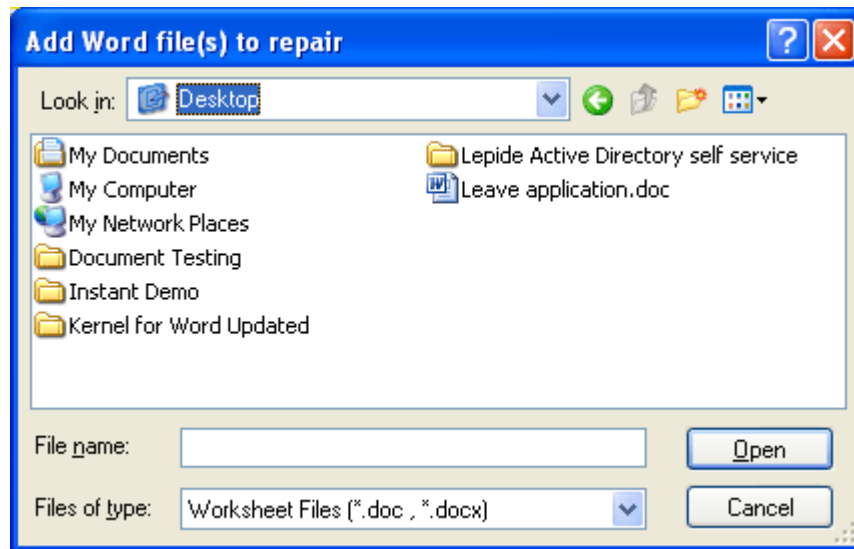


Figure 3.2.2 Add Files dialogue box

3. Select file(s) to repair and click the **Open** button. Selected file(s) will be listed in software:

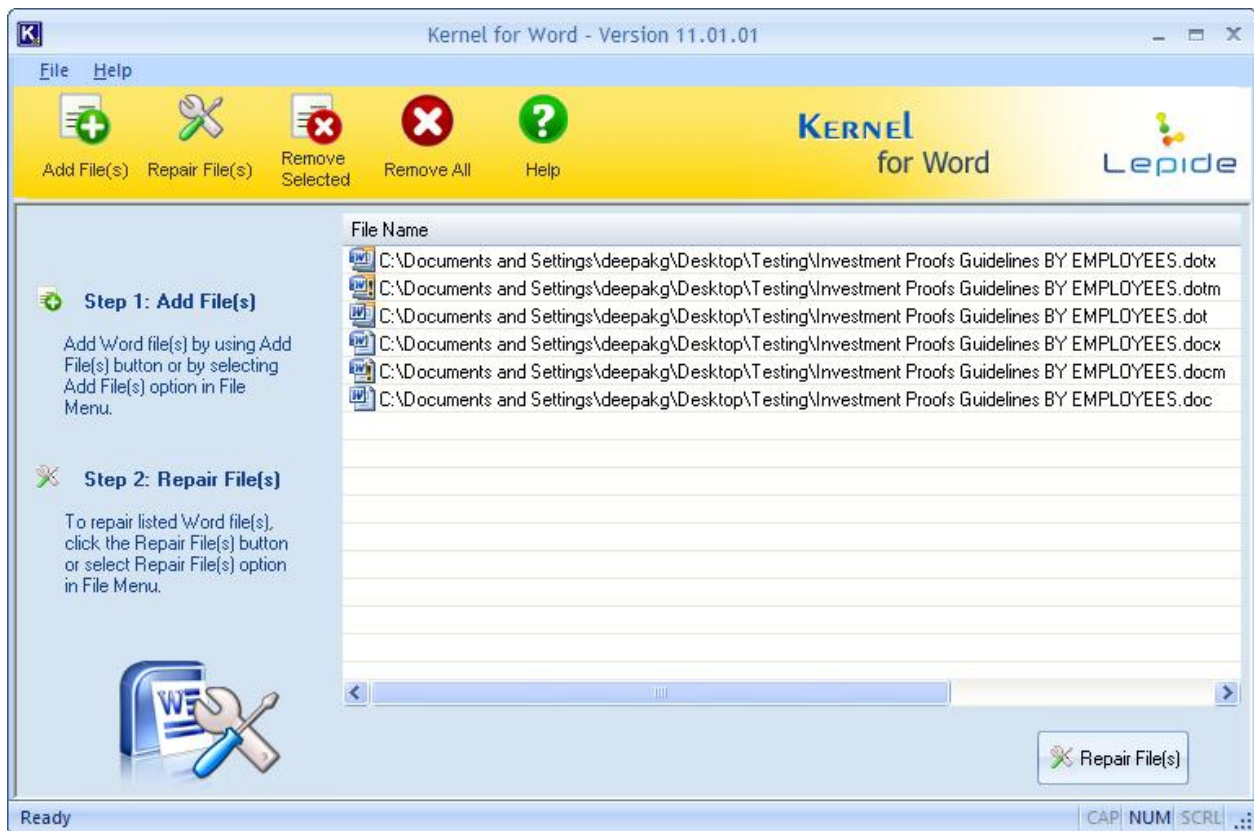



Figure 3.2.3 Selected Word Files

 You can select multiple .doc files to repair them in one repair cycle. You can remove any file from the list by selecting the file from the list and clicking **Remove Selected**. To remove all the files from the list, use **Remove All**.

4. Click the **Repair File(s)** button to move ahead in the repairing process. The "Browse for Folder" dialog box appears:

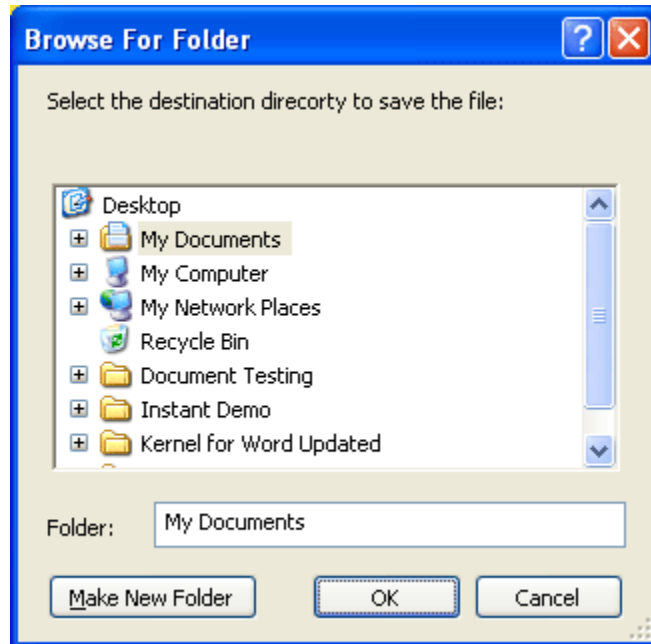



Figure 3.2.4 Browse for Folder

 Before clicking the **Repair File(s)** button, make sure that none of the Microsoft Word's instance is running. If any of the MS Word's instance will be running, Kernel for Word displays the "**Please, close all MS Word instance(s) before continuing the repairing process.**" message to let you inform that the repairing process could not be continued because one or more of the MS Word's instances are running.

5. Specify a location to save the repaired Word file(s) and click the **OK** button. As you click the **OK** button, the software starts repairing the listed Word file(s):



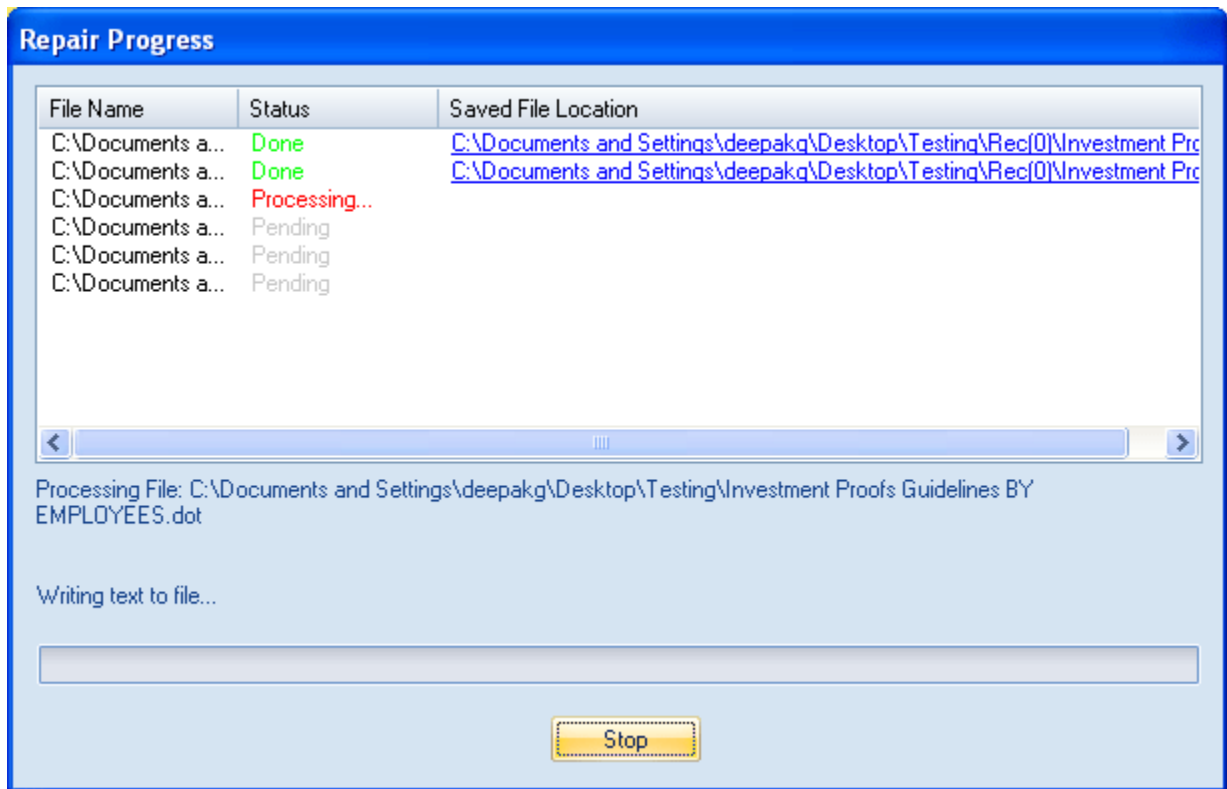


Figure 3.2.5 Repair Progress

Click the **Stop** button to terminate the repairing process in between.

- Click the **OK** button to close the dialog box and accessing the repaired files. After repairing the files, Kernel for Word displays link of the locations where the repaired files are saved. On clicking those links, the repaired files can be accessed immediately.

# 10. Full Version

---

Although you can use Kernel for Word evaluation version for free and experience the capabilities of the software but there are certain features that are not available in the evaluation version.

## 10.1 Requirement of Full Version

---

By using the evaluation version of Kernel for Word, you can repair corrupt .doc files; however, you cannot save the repaired files. You will need to buy the full version of the software to proceed with the saving process.

## 10.2 Purchasing Full Version

---

You can buy the full version of Kernel for Word from any one of our authorized resellers – Element5, Asknet and 2CO. As soon the purchase transaction with our resellers gets completed, our sales team will send you an email comprising the URL to download the full version of Kernel for Word and activation details of the software.

### Can it recover deleted Word files from my hard drive?

No, Kernel Word is a **File Repair Software**, it can only repair corrupt files. To recover your deleted Word file use Kernel for FAT + NTFS - Data Recovery Software
